Service Overview

SERVICE DESCRIPTION

The Total Market Volume service provides a daily instrument-level summary for UK securities of the volume traded across all market mechanisms, including primary exchange, Multilateral Trading Facilities (MTFs), Systematic Internalisers (SIs) and transactions executed Over The Counter (OTC).

The key benefits of the Total Market Volume report are as follows:

- Provides issuers with visibility of the total amount of trading taking place on UK securities, allowing UK trading volumes to be consistently compared to other jurisdictions.
- Enables market participants to determine total daily volume for UK securities across all mechanisms, instead of primary venue (LSE) only, thereby allowing accurate calibration of trading policies.

Subscribers can set up access to retrieve files on a daily basis.

Note that Total Market Volume information is sourced from the LSEG Data & Analytics Market Share Reporter product.

CRITERIA FOR INCLUSION IN THE SERVICE

The Total Market Volume product covers all **Equity** based instruments traded on the London Stock Exchange.

For clarity, instruments within the following London Stock Exchange segments are excluded from the Total Market Volume file:

CNVE, CRNR, CRTR, CWAT, CWNM, CWNR, CWNU, CWTR, CWTU, EQS, EXCQ, EXED, EXPE, EXPQ, GES1, GILT, GRME, GRMQ, GRNC, GRNE, GRPE, GRPQ, INCP, INSD, LVSD, MISC, MISL, MWNM, MWNU, MWTU, MXPE, MXPM, MXPQ, ODTT, ONAV, PSNR, PSTR, RCNM, RCNT, REOD, SSX4 (sector code SXEL only), STBS, SUKM, SUKP, SUNM, UKCP, UKGT and WQUO.

FILE AVAILABILITY

File Publication

The Total Market Volume files will be published on LSEG's Managed File Transfer (MFT) service.

Customers should refer to the separate Managed File Transfer Connectivity Customer Guide for instructions on how to get access to this service.

Note that the MFT service may not be available during weekend maintenance windows.

File Publication Time

The Total Market Volume file will be made available from 08:00am London time the following business day and will continue to be updated with amends/cancels as and when they are received.

The Exchange will take all reasonable steps to meet the above delivery times and dates, but such times and dates shall be estimates only and the Exchange shall not be liable for failure to meet them. In certain circumstances the publication of files will be delayed, for example on an extremely busy trading day. If a problem is encountered with the extraction process the Exchange will produce the files on a best endeavours basis.

OTHER NOTES

General

As of date of publication, the Total Market Volume does not contain volumes from transactions reported via Bloomberg APA or MarketAxess APA.

FILE FORMAT

Files are created in accordance with the following specifications:

Files will be compressed using gzip and will be published with a .GZ extension. Clients should use widely available software such as 7-Zip or WinZip to access the file contents.

FILE NAME

The files shall have the following naming format:

LSE_TMV_<YYYYMMDD>.CSV

For example:

LSE_TMV_20211026.CSV is TMV file for 26 October 2021 for London Stock Exchange vs Total Market Volume

The following data fields are included in the data file.

Trade Date	Date	Date on which the Instrument volume is calculated. Format: DD/MM/YYYY
Tradable Instrument Code	Char(12)	Together with the Country Of Register, Currency Code and Market Segment, this will uniquely identify a tradable instrument. This will be the International Security Identification Number (ISIN).
Tradable Instrument Display Mnemonic	Char(4)	The mnemonic code is allocated by the Exchange and used to identify a tradable instrument. (Note this is the LSE local currency (GBX,GBP) TIDM and may not be the same on other exchanges or currencies.)
Issuer Name	Char(35)	The full name of the issuer of a tradable instrument.
Country of Register	Char(2)	This specifies the Country of Register for a specific tradable instrument. This is an ISO country code (ISO 3166).
Market Segment Code	Char(4)	A code which uniquely identifies a specific trading area as defined by the London Stock Exchange.
Market Sector Code	Char(4	This code identifies a division of the market within Market Segment.
Daily Volume Total Market	Integer	The Cumulative trading volume for a tradable instrument for a trading day across all ¹ market mechanisms
