Market structure changes effective Monday 17 December 2018. Millennium Exchange CDS Maintenance notification.

The purpose of this Service Announcement is to advise customers of the following:

- changes effective on London Stock Exchange Millennium Exchange & TRADEcho Production from Monday 17 December 2018:
 - Amendment of associated settlement trading & settlement calendars attached to each Millennium Exchange Security;
 - The creation of 10 new trading sectors in 7 existing trading segments; and
 - The withdrawal of 28 sectors segments that have been redundant since the introduction of MiFID II.
- 2. Update in connection with Shanghai-London Stock Connect trading segments
- 3. Millennium Exchange Customer Development Service (CDS) will be unavailable on both Wednesday 5 and Thursday 6 December 2018.

Revision of Calendar Market Reference Data Files

All London Stock Exchange Millennium Exchange trading services follow the same trading holiday calendar dates, as set out at: www.lseg.com/businessdays

From Monday 17 December 2018, production Market Reference Data Files will have the existing 8 Calendars replaced by 10 new ones. This will allow greater flexibility for settlement holidays of different trading currencies than currently permitted. Withdrawal of 28 redundant sectors

Twenty-eight sectors that have been redundant at least since the introduction of MiFID II at the beginning of 2018 will be withdrawn. This means that the trading segments **SET0**, **AIM**, **AIMI** and **ITR** will also no longer be used going forward.

Shanghai-London Stock Connect

Shanghai–London Stock Connect is the new joint initiative allowing Shanghai Stock Exchange listed corporates to list GDRs to be traded on IOB, with UK Premium listed corporates being listed for trading on SSE. Service Announcement *01/28082018* issued on 28 August 2018, advised that 2 new IOB trading segments (IOBS & IOBT) were available on Production from Monday 3 September 2018. From this time a test security was also available on the CDS version of both IOBS & IOBT to help firms with their future development plans.

On 17 September 2018, Stock Exchange Notice N15/18 was published confirming that the revised *London Stock Exchange Admission and Disclosure Standards* to support the service will become effective from 1 October 2018.

Notification of securities to be added to the production Shanghai–London Stock Connect service will be in the usual way via the Datasync reference data service.

Customer Development Service (CDS)

To facilitate these changes, Millennium Exchange CDS will be unavailable on both Wednesday 5 and Thursday 6 December 2018. It is expected that the environment will be fully available as per usual on Friday 7 December 2018.
