The London Stock Exchange provides a range of services on its Millennium Exchange Live Service to facilitate its members trading needs.

1.1 Purpose

The purpose of this document is to provide participants with information on how to connect to the London Stock Exchange MillenniumIT platform for both the Customer Development Service (CDS) and the Production service.

1.2 Readership

This document is a supporting document to the interface technical specifications. When read in conjunction with the other technical specifications, these documents provide all of the details London Stock Exchange participants require to connect to the MillenniumIT trading platform.

This document is particularly relevant to project and technical staff within member firms and companies that provide the London Stock Exchange related services to member and non-member firms.

Users are expected to wait 500ms after sending the login requests to the gateways before they start trading activity.
