TRADEcho – Data Centre Migration – Key Dates Update

The purpose of this Service Announcement is to inform customers of key dates for the Data Centre migration for TRADEcho services on each customer environment (Customer Development Service (CDS), Legacy CDS and Production).

Customers should note that TRADEcho will <u>not be</u> running these environments in parallel at both existing and new data centres. The CDS, LCDS and Production services that run out of the existing Data Centre will cease to be operational on the dates listed below.

Date	Event
Monday 1 August 2022	TRADEcho CDS cutover to the new data centre
Monday 12 September 2022	TRADEcho LCDS cutover to the new data centre
Saturday 17 September 2022	First Customer Dress Rehearsal (CDR)
Saturday 1 October 2022	Second Customer Dress Rehearsal (CDR)
Saturday 15 October	Production go-live from new data centre

TRADEcho customers and those customers who consume TRADEcho market data via Group Ticker Plant (GTP) will need to connect to the new data centre IP addresses to access the CDS, LCDS and Production environments from the above-mentioned dates. Further information regarding testing at the new data centre for each environment (CDS, Legacy CDS and Production) will be provided in due course as will Customer Dress Rehearsal guides.

TCP Responders will be made available for customers to test connectivity prior to the new data centre cutover dates. The dates when TCP responders will be available for customer testing will be announced in due course.
